

PETITION FOR RE-INSTATEMENT FOLLOWING DISQUALIFICATION

You may petition for a one time exception and reinstatement by submitting this petition with approval of your department. Submit the approved petition to your Continuing Student specialist in the Division of Graduate Studies. You must be able to improve your GPA in one semester or you will be permanently disqualified.
